Dear parent(s)/guardian(s),

We handle these photos and videos with care. We do not post images that could harm students. We are required by law to ask your permission for the use of visual material of your son/daughter if he/she is under 16 years of age.

It is good to discuss giving permission with your son/daughter. If you discuss your choice at home, they will know for themselves why the use of photos and videos is or is not allowed. It is possible that you do not want photos of your child to appear on the Internet.

Your permission applies only to images taken by us or on our behalf. It may be the case that other parents/carers take photographs during school activities. The school has no influence on this, but we trust that these parents/carers will also exercise restraint when posting and sharing images on the internet.

With this letter we ask you to indicate for what purpose De Eglantier Delft may use visual material of your son/daughter. On the permission form you can see for what purpose the different options are used.

If we want to have visual material taken for research purposes, for example to record a lesson taught by the internship teacher, we will inform you separately and ask for your permission if necessary. We will also contact you if we want to use visual material for a purpose other than that stated on the reply form.

Of course, you may always withdraw the consent you have given. You may also give permission at a later date. Without permission, no visual material of your son/daughter will be used and shared.
